Minutes of the Accreditation Committee Meeting held in the Chamber  
of Secretaries, Local Self Government Department  
on 20.02.2014 at 2.00 P.M.

The meeting began at 2.00 P.M. Sri.Rajan Khobragade, Secretary, Local Self Government Department in the chair.

The Committee examined all the 16 proposals received from NGOs/Agencies. They are,

After a detailed discussion the Committee decided to select agencies engaged in and having expertise in Civil Projects-Construction works executed as per the approved SOR.

The Committee decided not to consider application for accreditation in areas of waste management, biogas etc as Suchitwa Mission is having Accreditation System in this field and another Accredited Committee need not consider such application.

The Committee also decided that the services for which the TOR and Financial quote are not well defined cannot be considered for accreditation. The Committee selected the following Agencies/NGOs as accredited Agency for the execution of works noted against each agency as per approved SOR.
